The committee on receiving complaints will set up an Enquiry Committee which will review the case/ conduct disciplinary proceedings against concerned person(s) and recommend further action within a stipulated time. If it is found that the complaint is false, the Committee will recommend an action to be taken against the person making the complaint this is best achieved throughout the year by promoting gender sensitivity among students and employees.

The college has organised the programme, topic **Importance of Cyber Security** on 13<sup>th</sup> December 2017 to promote physical, mental and social wellbeing of the female students of our college. The resource persons for this programme were lady Police Inspector, Mr.Kokate, Deputy Police Commissioner, Mr.Thakur, Asst. Police Commissioner, Mr.Davale, Police Inspector Deolali Camp Police. She delivered an Excellent Speech and Guide our Female Staff and Students. She explained in detail, how to use social media securely. The Workshop was very informative and interesting. The girl students feel safe as such programs create awareness among them.

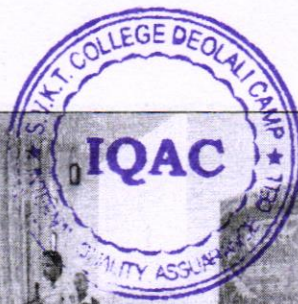
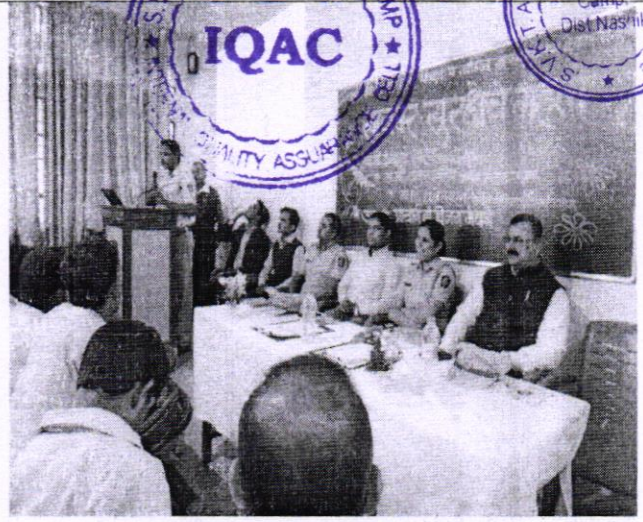
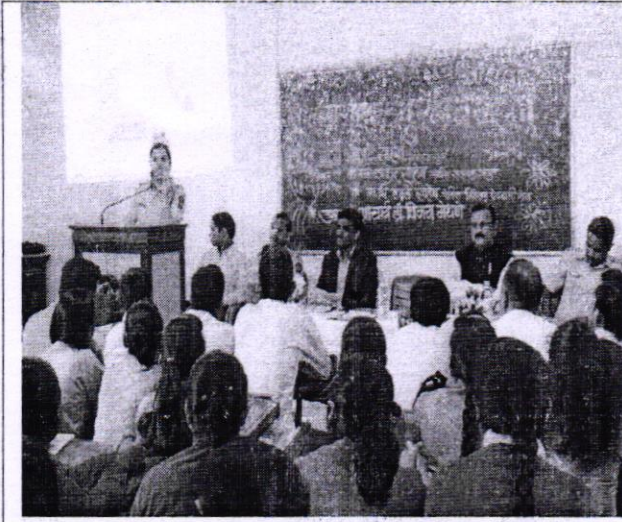
